In 2019, our Community benefit totaled \$2.9 Million

The Village at Marymount is a ministry of the Sisters of St. Joseph of the Third Order of St. Francis that provides assisted living, skilled nursing, rehabilitation, memory care, hospice, and respite care to individuals and caregivers who seek a Catholic-based care facility with a commitment to healthy living. The Village at Marymount is a place where residents experience innovative programs and services, provided by compassionate and competent staff members, designed to keep residents living life to the fullest extent possible. It is made up of Villa St. Joseph (130-bed nursing facility, 12-bed memory care assisted living) and Marymount Place (104-bed assisted living community.

MEDICAID SHORTFALL \$2.1 Million

The Village at Marymount is a leading provider of Medicaid services in the community. The Medicaid program, which provides health care coverage to low-income families and individuals, is funded by state and federal governments. In many states, including Ohio, Medicaid payments have not been sufficient to cover the costs of tre ting Medicaid beneficiaries In 2019, our Medicaid shortfall was \$2,046,000.

FINANCIAL ASSISTANCE \$275,000

Financial assistance is the amount of free or discounted medically necessary care provided to those patients unable to pay some or all of their bills. The Village at Marymount has a financial assistance polity that provides free or discounted care to patients with incomes up to 400 percent of the federal poverty level. OUTREACH PROGRAMS \$23,000

The Village at Marymount is actively engaged in a broad array of outreach programs, many of which are designed to serve the most vulnerable and at-risk populations. Outreach programs address documented health needs identified in our communit .

In their words, "Mom loved living at Marymount Place almost 2 ½ years. She loved that when she was ill and needed therapy she could be in Villa St. Joseph where friends from assisted living could come and visit and she could be taken to

her room to get things and be assured they were waiting for her. When it became evident she was not getting better, she was able to move into Clare Hall and be loved and cared for on hospice without having to leave the campus she had come to love."

They also shared that the highlight of her last months was getting a more comfortable geriatric chair they used to take her to the Sisters' outdoor Shrine for a special Sunday Mass. Bishop Emeritus Roger Gries, OSB, presided at the Mass and spent time mingling with attendees afterward. He gave Dolores a special blessing and took a few pictures with her. The next day she couldn't stop smiling as she told all the staff and visitors her "rest of the story" which was that "the Pope" even came and blessed me and kissed me on the cheek!" Her sons saw their Mom beaming and happy; Dolores saw the face of God coming to her in the person of Bishop Roger.

Beautiful Smile, Joyous Fun-filled Life

Louis Wachala had aged into being a "repeat resident" at Villa St. Joseph. One or another health issue found him in the therapy gym announcing, "I'm back!" to the therapists-become-friends he constantly entertained.

At the end of one of his visits, he told his kids he didn't want to leave, they needed to move him into the assisted living building. He dived into life at Marymount Place and loved it. He was no longer home alone; he ate with others; he walked down the hall to Mass; he sat outside "catching the rays" every chance he got; he even played poker (sometimes "with nuns"!) and he attended every Friday Happy Hour in the living room.

He told Sister Mary Alice Jarosz, Director of Mission Integration, "You know my sister, Sister Mary Theophane loved living here and so do I. She's in heaven now and hopefully she'll see me and get me in too!"

Louis' kids told us "the rest of his story": "He absolutely loved living here. He was always happy, fun and ready for a party, but we had watched him slowing down and losing ground. When he moved into Marymount Place, we saw with our own eyes that he was beaming, it was like he came totally alive again. We'll never forget his constant smile!"

We see him smiling down on his family and, hopefully, on us as well and wanting to tell us all the final line of the rest of his sto y!



From Vendor To The Villa

The Village at Marymount has an internal television channel where residents can catch up on the latest events, pictures, and enjoy a bit of trivia.

"I have a trivia guestion for your TV channel," said Villa St. Joseph resident James "Hoss" Hosack. "Which resident used to be a souvenir vendor for 14 years at the old Cleveland Stadium?" His answer? "Me!"

Hoss recalled his days as a Cleveland Stadium souvenir vendor with great fondness and pride. During the Cleveland Indians' final homestand t the Stadium (October 1-3, 1993 vs. the Chicago White Sox), Hoss said he went to work at 8 a.m. on Friday, October 1, and didn't leave his post until 4 p.m. the next day.

"I fell asleep in my office" Hoss said. "The Big Boss found me in my office and asked my boss why I was sleeping When he was told I had been at work since 8 o'clock Friday morning. the Big Boss had someone drive me home."

The Indians lost the Stadium finale 4-0. After the game, legendary entertainer Bob Hope sang his trademark song "Thanks For The Memories" amid the post-game lovefest that featured the removal of home plate as fans stood and snapped pictures with Tribe players.

"I got to meet Bob Hope after the game," Hoss recalled. "I said, 'Mr. Hope, it's nice to meet you.' He looked at me with a scowl on his face. Then he said, 'Mr. Hope was my father. You call me Bob.' I'll never forget that."

Today, Hoss is a fixture t Villa St. Joseph. A resident of the Continuing Care
